1. The fee for this league is \$250.00.
2. Each team pays \$30.00 to the officials prior to their regular and post season tournament games. A \$60.00 forfeit fee (ref fees for both teams) will be paid for all team forfeits. No team will play their next game until the forfeit fee is paid. \$60.00 fee must be on file in Rec office prior to first game.
3. The rosters must be signed prior to playing.
4. The last day to add players to your roster is February 20, 2020.
5. All games will be at the Recreation Center in the New Gymnasium.
6. Games will start at designated times. NO GRACE PERIOD.
7. A team may start and play with four players.
8. The last four minutes of the second half is regulation clock, unless one team is twenty or more points ahead.
9. In the last two minutes of the second half, all fouls are two shots.
10. Each team gets two timeouts per half.
11. The season will be followed by a double-elimination tournament.
12. The schedule will not be adjusted to accommodate and individual teams or players.
13. If you bring children to the game, you are responsible for their safety and behavior.
