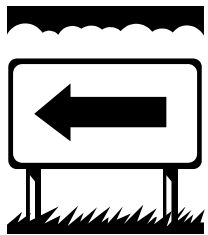


Signs Not Subject To Permit Requirement

* Official notices that provide information by any public officer in the performance of a public duty or by a person giving legal notice. An example is a sign directing people where to vote.



* Functional information signs that provide direction, warning and functional information when installed and maintained by an official body. An example is a sign giving parking directions.



Signs displaying non-commercial messages such as opinions on matters of religion, politics or social policy may be displayed at any time and in any zone.

* In residential zones, these signs are subject to a maximum area of six (6) sq. ft. per sign; maximum two (2) signs; maximum height is four (4) feet; illumination is not allowed. If the sign is permanent, than all applicable building and safety code requirements shall be met.

Temporary Increase In Non-Commercial Message Signs:

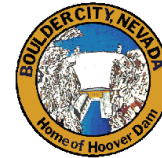
- * During the time sixty (60) days before any primary, special or general election, and ending five (5) days thereafter, the amount of sign area used for non-commercial speech messages may be increased as follows:
 - ◆ In commercial and industrial zones, an additional eighteen (18) sq. ft. of sign area is allowed.
 - ◆ In residential zones, an additional fourteen (14) sq. ft. of sign area is allowed.

Standards for Temporary Signs

The “Basics”

Temporary signs may not flash, blink, be illuminated, spin, rotate, block traffic visibility, constitute a vehicular or pedestrian traffic hazard or cause a public nuisance of any kind.



Temporary signs **SHALL NOT BE ATTACHED** to utility poles, fences, trees or other public property. They must be secured to the building, interior

parking lot light pole or ground. Temporary signs may be attached to existing permanent signs.

When Temporary Signs are allowed:

Temporary signs are allowed for holiday promotional periods without a permit.

One (1) banner sign, not to exceed thirty-two (32) sq. ft. is allowed. It must be secured to the building and removed by the end of the first working day after the holiday.

Holiday Period for display of temporary signs: During most holiday periods, businesses are allowed to display temporary signs without a permit. The permitted display time for the holiday periods below are five (5) days including the holiday. Examples of the holidays listed in the ordinance are:



Presidents' Day and Valentine's Day—February

Easter—March or April

Memorial Day, July 4th, Labor Day and Nevada Day, October 31st

- * Thanksgiving—Permitted display time is seven (7) days including the holiday
- * Hanukkah, Christmas, New Year's—Permitted display time begins December 10 and ends January 2.

Special Promotions Periods:

A business may apply for three (3) special promotion periods during a calendar year. Each period may not exceed seven (7) days. A single banner, not to exceed thirty-two (32) square feet, is allowed. It must be attached to the business structure/lease space. One (1) banner is allowed per elevation facing a public street. The three periods may run consecutively.

Temporary Signs for Real Estate Transactions and Non-Commercial Messages:

- * On Site: Signs relating to a proposed real estate transaction or any non-commercial message **MAY BE PLACED ON PRIVATE**



PROPERTY: maximum display face of six (6) sq. ft. per sign; maximum height four (4) ft.; illumination not allowed; maximum number of signs at any one time on any one parcel is two (2).

- * Off Site: Signs relating to a proposed real estate transaction or any non-commercial message **MAY BE PLACED ON PRIVATE PROPERTY:** maximum display face of twelve (12) sq. ft. per sign; maximum height four (4) feet; display time is 6 a.m. to 10 p.m.; illumination not allowed; maximum number of signs at any one time on any one parcel is three (3).

REMEMBER—no signage of any kind is permitted in the street right-of-way. Typically, the right-of-way extends from back of sidewalk, across the street to the other back of sidewalk. Street medians are in the right-of-way and are off-limits!
