1. For possible action: Approval of the Minutes of the March 17, 2021 regular meeting
2. For possible action: V-21-651 – Aaron Medo – 376 Laurel Drive: A **public hearing** on an application for a variance in the R1-15, Single-Family Residential Zone for an addition which results in a combined side setback of 9.35', whereas Section 11-3-5.B of the City Code requires a minimum combined side setback of 15'
3. For possible action: V-21-652 – Jeffrey Bellows – 971 Fairway Drive: A **public hearing** on an application for a variance for structures (already built) in the R1-7, Single-Family Residential Zone:
 - A. A request to permit an accessory structure 1,485 s.f. in size that is a similar color but not material to the house, whereas Section 11-20-2.B.3 of the City Code limits accessory buildings to a maximum area of 1,000 s.f. only if of similar material and color to the house
 - B. A request to permit a wall 6' in height within a portion of the required front yard, whereas Section 11-20-4.B.1 limits wall height to a maximum of 4' within a required front yard

Each person has up to five minutes to speak at the discretion of the Chair. Comments made during the Public Comment period of the agenda may be on any subject. All remarks shall be addressed to the Planning Commission as a whole, not to any individual member of the Planning Commission,

of the audience, or of the City staff. There shall be no personal attacks against the Chair, members of the Planning Commission, the City staff, or any other individual. No person, other than members of the Planning Commission and the person who has the floor, shall be permitted to enter into any discussion, either directly or through a member of the Planning Commission without the permission of the Chair or Presiding Officer. No action may be taken on a matter raised under this item.

All decisions for action items on this agenda are final by the Planning Commission, unless they are recommendations to the City Council, or appealed to the City Council. Appeals must be filed within seven (7) calendar days of the decision in accordance with Chapter 11-34 of the Boulder City Code.
