RESULTS OF CANVASS OF THE 2024 PRIMARY ELECTION IN THE CITY OF BOULDER CITY JUNE 11, 2024

The results of the June 11, 2024, Primary Election were canvassed comparing the computer printout of ballots counted and the results thereof, with the official ballot statement for each of the 6 precincts utilized in this election.

There were no discrepancies in the 4,339 ballots cast in the 6 precincts. There were no tabulation errors in the 6 precincts in the Primary Election.

Five (5) provisional ballots were cast during the election, three (3) were verified and counted and two (2) were not registered to vote.

Audits were performed according to NRS 293B on the hash code of our ICX voting machines and the VVPAT rolls for 2% of all machines used in the election. No discrepancies were identified. The accuracy certification board also certified the functionality of our tabulation system, to include our mail readers, ICX voting machines, and Agilis mail ballot processing machine. All systems were found to be 100% accurate in the tabulation of votes and processing of mail ballots. The tests were performed before the start of early voting, the day before Election Day, and a post-election test the day after the election.

There were no tabulation errors in the 6 precincts. Therefore, as the duly appointed Registrar of Voters of Clark County, Nevada, I do hereby certify to the Clark County Board of Commissioners that the results of the canvass of this election are deemed certifiable.

Fleeing Voters: (NO DISCREPANCIES)	We determined most of these are indeed voters who checked in but did not vote.
Reactivated Card Improperly/Extra Vote Cast: (NO DISCREPANCIES)	There were several VVPAT printer errors; in some cases where the ICX had an error message after a voter cast a ballot, the voter would think the vote did not process. If the Team Leader did not follow the proper procedures of checking the status of the voters card to determine if the vote was cast, then there may have been an extra vote cast.
Cancellation Error: (NO DISCREPANCIES)	We determined most of these are indeed voters who had issues with their cancellation process.
