RESULTS OF CANVASS OF THE 2024 GENERAL ELECTION IN THE CITY OF BOULDER CITY NOVEMBER 5, 2024

The results of the November 5, 2024, General Election were canvassed comparing the computer printout of ballots counted and the results thereof, with the official ballot statement for each of the 6 precincts utilized in this election.

There were four (4) discrepancies in the 10,272 ballots cast in the 6 precincts. There were no tabulation errors in the 6 precincts in the General Election.

One hundred thirty (130) provisional ballots were cast during the election, one hundred two (102) were verified and counted and twenty-eight (28) were not eligible to vote.

Audits were performed according to NRS 293B on the hash code of our ICX voting machines and the VVPAT rolls for 2% of all machines used in the election. No discrepancies were identified. The accuracy certification board also certified the functionality of our tabulation system, to include our mail readers, ICX voting machines, and Agilis mail ballot processing machine. All systems were found to be 100% accurate in the tabulation of votes and processing of mail ballots. The tests were performed before the start of early voting, the day before Election Day, and a post-election test the day after the election.

There were no tabulation errors in the 6 precincts. Therefore, as the duly appointed Registrar of Voters of Clark County, Nevada, I do hereby certify to the Clark County Board of Commissioners that the results of the canvass of this election are deemed certifiable.

Post-Election Certification 2024 General Election

Audit of Voter Verifiable Paper Trail Printers

In accordance with Chapter 293B of the Nevada Administrative Code, an audit was conducted of 87 (2% of 4,350) machines used in the election. The randomly selected ICX touchscreen voting machines, and the voter verifiable paper trail printer that was used with each machine, were used in this audit. The audit was conducted as follows:

- a. For each machine selected, the printed record produced by the machine during voting was manually tabulated by a panel of Clark County Election Department staff members.
- b. The electronically recorded results for each machine were independently tabulated using the election tabulation software.
- c. The results were compared.

The results of the audit showed that 100% of the time, the electronically recorded results exactly matched the selections printed on the paper tape.
