



[Smart Thermostat Rebate Program Eligibility Requirements](#)

The Smart Thermostat Rebate Program is available to all Boulder City residential electric customers. The following eligibility requirements apply:

1. You must be a current Boulder City electric service customer.
2. Smart thermostat must be ENERGY STAR certified. View the current list of ENERGY STAR certified smart thermostats with the link below.

3. A completed rebate application form must be submitted within **90 days** of the installation date.
4. A dated contractor invoice, if a contractor was used, will be required as proof of installation date.
5. Residential purchasers of qualifying equipment may be subject to an on-site inspection by a Boulder City representative to verify equipment is properly installed and operational.
6. Rebate amounts are \$75 per thermostat or fifty percent off the MSRP, whichever is less.
7. Customers must fulfill all program guidelines and submit a complete rebate application form and all applicable transactional data to be eligible for incentives.
8. Submit all documents described in the Submittal Checklist.
